FIRST AMENDMENT TO MEMORANDUM OF UNDERSTANDING BETWEEN TARRANT COUNTY COLLEGE DISTRICT AND BIRDVILLE INDEPENDENT SCHOOL DISTRICT COLLEGIATE ACADEMY OF BIRDVILLE ECHS

This First Amendment to Memorandum of Understanding Between Tarrant County College District and Birdville Independent School District Collegiate Academy of Birdville ECHS (the "Amendment") is entered into by and between Tarrant County College District and Birdville Independent School District as of this 1 day of November 2022.

WITNESSETH:

WHEREAS, Tarrant County College District and Birdville Independent School District entered into that certain Memorandum of Understanding Between Tarrant County College District and Birdville Independent School District Collegiate Academy of Birdville ECHS (the "Contract") as of July 15, 2021; and

AND WHEREAS, the parties desire to modify the terms of the Contract as hereinafter provided,

NOW, THEREFORE, for and in consideration of Ten and No/100 Dollars and other good and valuable consideration, the receipt and sufficiency of which is hereby agreed by both Tarrant County College and Birdville Independent School District, the parties agree as follows:

- 1. Section "Furniture and Equipment" of the Facilities Use Agreement will include the following:
- BISD will provide the chairs at the ECHS and TCC will provide all other furniture including desks, tables
 and other items required for courses it intends to offer at the ECHS. If TCC determines a need to offer
 evening classes at the ECHS site, TCC would provide, maintain, and store its own equipment. TCC shall
 be responsible to track and inventory all equipment purchased by TCC and placed or installed at ECHS.
- Both BISD and TCC agree to repair and maintain any furniture and equipment they own to their respective
 industry certifications and shall replace any of such furniture and equipment that is damaged beyond
 repair with equivalent replacement(s) that satisfy the respective organization's standards of selection.
 However, if it is conclusively determined that a party, its agents, employees, invitees, or students was
 responsible for damage to furniture or equipment at the ECHS, said party shall have the right to seek from
 the individual responsible the necessary repair or replacement.

The following will be removed:

- TCC will provide and own the furniture, fixtures, and equipment (the "Furniture") reasonably necessary for the operation of the ECHS
- All Furniture must comply with TCC standards of selection.
